Guidance for documenting State Assessment accommodations on IEPs

- IEP teams <u>will not indicate</u> "all appropriate and/or allowed accommodations". This statement <u>does not meet</u> the requirement under IDEA which states "each student's IEP must include a statement of any individual accommodations". If selected, **Designated Supports** and **Documented Accommodations** must be documented on the IEP. **Universal Tools** are available to all students. Any of these tools deemed necessary for a student on a 504/IEP must be documented in order to assure implementation.
- IEP teams document specific accommodations on Statewide Assessment page under the appropriate rows labeled "Reading/Literature, Mathematics, and Writing".

For Smarter Balanced category of "Listening", IEP team will identify any individual accommodations under

- "Reading/Literature" on the Statewide Assessment page OAKS (Science and Extended Assessment)- No changes at this time.
- 5. OAKS- IEP teams will continue to document **any individual accommodations** for ELPA, KA and NAEP on the Present Levels of Academic Achievement and Functional Performance section of the IEP.
- 6. If an IEP has been conducted and is not scheduled for an Annual Review before testing begins (mid-March 2015), then the IEP will need to be revised. The purpose of the revision is to document necessary accommodations using the SBAC Accommodations Guideline. The following are allowable methods for changing an IEP:
- A revision IEP team meeting.
