STUDENT ORIENTATION-BEHAVIOR EXPECTATIONS

- 1. Attending classes regularly and on time is important. Students who skip or who are frequently late to class are subject to detention or suspension from school. Students are to remain in class until released by the instructor.
- Drugs and alcohol are forbidden at school. Students are not to use, posses, sell or transfer alcohol or illegal drugs or look-a-like substances at school or at school activities. Violations lead to a hearing that may result in suspension from school and school activities or expulsion from school. Violations will be reported.
- 3. The school district prohibits clothing or displays, which are: sexually suggestive, drug related, vulgar or insulting, demeaning to a particular person or group or indicative of gang membership. Students may be directed to change dress or grooming if it interferes with the learning process or school climate.
- 4. It is a felony to possess a firearm or other weapon on school property. All violations of state weapons laws will be reported to the school police. Any student who brings a weapon to school faces federally mandated expulsion for one calendar year.
- 5. Students are expected to respect the rights and properties of others. Students should not litter the neighborhood. Cars and bikes should be ridden with consideration for the property and safety of the neighborhood.
- 6. Students may not possess knives, razors or any other instruments capable of inflicting injury to person or property. This includes look-a-like weapons. Lockers and other places where students keep things are the property of the school and may be checked at any time by the school for dangerous and prohibited items. Students' vehicles are also subject to search for dangerous or prohibited items.
- 7. Students who need to take medication at school must make arrangements with the school nurse. The parent or guardian will make arrangements for the student to receive the medication. Any medication must be in the original labeled container.
- 8. Sexual harassment of an individual student or a group of students is prohibited. This includes, but is not limited to: letters, notes, phone calls, touching, leaning over, cornering, pinching, sexually suggestive looks/glances, pressure for sexual favors, pressure for dates, sexual teasing, jokes, remarks or questions.
- 9. Harassment or discrimination against persons on the basis of age, color, creed, disability, race, religion, sex or sexual orientation is prohibited and is subject to school discipline.
- 10. The use of tobacco products is prohibited in school district buildings and grounds at all times.
- 11. Juniors and seniors are allowed to leave campus at lunchtime. They are expected to return on time for their next class. Freshmen and sophomores are not allowed to leave campus during the school day.
- 12. Students must have a hall pass when in the halls during class time. It is the student's responsibility to obtain a pass before leaving the room. Teachers will not issue a hall pass during the first or last ten minutes of the period. Vending machines are off limits during class time.
- 13. Hazing/initiation in any form is strictly prohibited and will not be tolerated. Students should report incidents involving hazing or initiation to a staff member.
- 14. Students need parent/guardian permission to be released during the school day. Students will check out at the CAO office and then check in upon their return.

- 15. Students will register their cars with Wilson High School. Students who violate parking regulations are subject to parking fines, towing or removal from the parking lot.
- 16. All athletic equipment must be kept in lockers. Basketballs may be taken to the gym only during lunch.
- 17. Electronic devices are discouraged at school. Bring these items at your own risk. Students disrupting class with electronic devices will have them confiscated.
- 18. Skateboards, roller-skates or in-line skates are prohibited during school time on school property. These items are to be left in lockers during the school day.
- 19. Fighting, assault and physical altercations will not be tolerated. Students involved in physical confrontations will be suspended.
- 20. Throwing items of any kind is strictly prohibited in all areas.

Disciplinary Action Levels

- 1. Conferences
- 2. Interventions/detentions/work details. Students are to complete detention or work detail within 48 hours of receiving detention or work detail.
- 3. Suspensions/Temporary removal/Reassignment
- 4. Expulsion/Reassignment
- 5. Mandatory Expulsion
- 6. Federally Mandated Expulsion

Definitions

Detention – 45 minutes before/after school

Work Detail – 15 minutes of cleaning during lunch (Two work details = 1 before/after school detention.)

Work Detail Saturdays – with the campus monitor for up to four hours.

Suspension - temporary removal from school and school activities.

Expulsion – removal from school for up to one year.

Federally mandated expulsion – mandatory expulsion for one year.
