### How will changes happen?

Boundary changes will begin in Fall 2023 with incoming kindergartners or 6th graders and any other newly arriving students. Currently enrollment students may remain in their schools through the highest grade, or opt-into their new boundary school by applying for transfer at <a href="https://www.pps.net/schoolchoice">www.pps.net/schoolchoice</a>.

Program moves, including language immersion, Creative Science and Harrison Park K-5, will happen all at once in Fall 2023. The pace of change for Lent students in the English-only program will be determined by school leaders as part of the transition to a whole-DLI school.

### Southeast Enrollment and Program Balancing


In 2020, the PPS Board of Education charged a volunteer Guiding Coalition to support the opening of two middle schools in Southeast Portland, while also addressing school overcrowding, low enrollment and challenges due to having multiple programs on the same campus. The goal of the work is to improve access to strong academic programs and create conditions in our school buildings that enhance student success.

Phase 1 resulted in an enrollment plan for Kellogg Middle School, which opened in Fall 2021. Phase 2 focused on the conversion of Harrison Park K-8 to a middle school, and on strengthening enrollment at Lane Middle School. The SE Guiding Coalition reviewed 15 options and considered input from hundreds of community members. The plan that received the most Coalition support serves as the basis for Deputy Superintendent Claire Hertz's recommendation to the PPS Board of Education. The Board will discuss the recommendation on May 10 and vote on May 24. Approved changes will take effect in Fall 2023.
