# Robert Gray Middle School Personal Electronic Device Agreement

"Device" means all personal technology devices (phones, tablets, laptops, Chromebooks, etc.)

Student:	

#### **STUDENTS WILL:**

- Use device only for academic purposes with teacher permission in class
- Keep device off and out of sight unless being used for academic purposes in class
- Use only school computers during teacher, library or office assistant time
- ☐ Leave device in class or locker if leaving the classroom
- Go to the office with permission to text or call a parent/guardian
- Give device to school staff when requested without argument
- Fill out a problem solver form for return of device from office

#### **PARENTS WILL:**

- Discuss personal use guidelines (see other side)
- Learn individual classroom technology policies
- Review device requirements with child and clarify expectations for both personal use and during class time
- Review "Ready to Learn" and "Personal Time" guidelines
- Have contact with child by phone/text during class time through the main office only and only for emergency purposes
- Read & review the required Problem Solver if there are issues

#### **TEACHERS WILL:**

- Teach, clarify and enforce RGMS guidelines
- Allow only academic use of devices during class time
- Be explicit about when devices can be used and when they cannot in class
- Maintain a system for leaving devices in the classroom
- Call for office escort for students needing to use a device during class time to contact parent/guardian
- Send devices to the office immediately for students to retrieve at the end of the day if confiscated
- Notify parent/guardian and give problem solver forms to the office

## **STUDENTS WILL:**

- □ Behave in appropriate manners online at all time
- Use only their own devices and refrain from taking/touching others' devices and chasing
- □ Take photos and videos only with the permission of everyone in them
- □ Move away from fights or altercations and refrain from videotaping them
- ☐ Give cell phone to school staff when requested without argument
- ☐ Fill out a problem solver form for return of cell phone

## **CONSEQUENCES for FAILURE TO FOLLOW REQUIREMENTS:**

- Step 1: Warning: Student will be counseled on violation and requirements and Problem Solver will be started
- **Step 2: Confiscation:** Device will be confiscated and returned to student at the end of the day from the main office after filling out the Problem Solver
- **Step 3: Parent Pick-Up:** Device will be confiscated and picked up only by parent/guardian after student fills out the Problem Solver with parent's input.
- Step 4: Personal Electronic Device Use Plan: An individual use plan will be created for the student

We understand that personal technology use is a privilege that comes with specific requirements.

We agree follow the RGMS personal technology requirements and understand that there are consequences for failure to follow the RGMS personal electronic technology agreement.
