Eating in the Careteria

I've had some parents inquire about the reason for eating only in the cafeteria. I had originally planned to continue with choice eating, but I learned from nutrition services that the option is not available without risking a loss of funding for student meals and the staff who serve them. Please see the communication I received from the Nutrition Services department below:

Last year the federal government gave us permission and flexibility in our services to match COVID protocols. Congress did not approve these flexibilities moving into this new school year. This means that our meal services should look similar to how they were in 2019. This includes students eating in a congregate area such as the cafeteria or commons area for lunch and either the classroom or cafeteria for breakfast. All PreK and Head Start classes eat all of their meals (breakfast, lunch, snack) in the classroom.

For those who were looking for the language specifically -

Under the Richard B. Russell National School Lunch Act at 42 USC 1753 (b) (1) (A) and 42 USC 1761 (a) (1) (D), and program regulations at 7 CFR 225.6 (e) (15) and 226.19 (b) (6) (iii), child nutrition program meals must be served in a congregate setting and must be consumed by participants on site... Congregate meal service is required (children must be served and eat each meal on site in a supervised setting).

Our outside services for breakfast last year were viewed as a grab and go model allowed only under the March 2020-June 2022 waivers, and would not meet this requirement. NS staff serving outside was bargained with SEIU and was not discussed for this school year. Please note that anything outside of what is permitted jeopardizes our funding that pays for our students' food and our staff. So we truly appreciate your support with these changes this year.

COVID Updates

During the 22-23 school year, masks will continue to be optional. Staff and volunteers are required to be fully vaccinated. We will continue to have three lunch periods so students can

be spaced farther during meal times. Please see the linked slide deck for more detailed information. The newly created COVID self screening checklist is linked here as well.

School Safety Measures

In light of recent horrific events, a number of parents have reached out to me to inquire about the safety measures in place at Peninsula:

- We will continue to require that all visitors and volunteers undergo the volunteer background check.
- To enter the building you will need to be buzzed in through the main door, and will only be allowed in if you are scheduled to visit or volunteer. All other doors remain locked and closed during the school day.
- There are cameras on the main door, as well as the door by the parking lot.
- All classroom doors are locked. Most classrooms have a "door duty" student job to open doors for visitors to the classroom.
- We have drills that we practice a few time each year, but because they can be traumatic
 for students, most of the drill work is adults practicing our protocols, with as little impact
 to students as possible.
- All gates to the playground and courtyard are locked during school hours.
