Dear Roseway Heights Families,

We had a very successful Food Drive last week and raised over 6,000 pounds of food - thank you to everyone who helped or contributed - it all goes to support the Oregon Food Bank. Next week is our **Scholastic Book Fair.** For the first time in several years the Book Fair will be set up in our library instead of the small gym. Please take advantage of supporting both the love of reading and this fundraiser that supports our PTA.

I want to introduce to you our new library assistant **Brenda Jamsgard**. Monday was her first day and she will be here full time supporting Stuart Levy in our library. I've known Brenda since my time as the Markham Principal and I'm excited to have her joining us.

This week Mrs. Mosel and I have been speaking with each of the middle school core classes about the district's anti-harassment policy. Our goal is have them think about being allies instead of bystanders when bullying situations arise and for them to feel empowered to speak up when something is happening that doesn't feel right or safe. The vast majority of our students do a great job in making decisions the majority of the time and we want to be proactive in reminding them of this and help them continue to do so. One of the issues Mrs. Mosel and I struggle with is students coming forward and letting us know when bullying is occurring, so our other goal is encouraging students to tell a trusted adult as soon as possible so we can intervene as soon as possible.

I have attached two documents to this newsletter. One is information for families on cyberbullying and the other is one on frequently asked questions around bullying, both produced by PPS.

After spring vacation, students in grades 3-8 will begin the practice tests for the **State Smarter Balanced** tests. Students in all those grades take tests in both language arts and math and additionally students in grades 5 and 8 take an OAKS science test. Parents do have the right to opt out of any or all of those assessments and to do so need to complete the parent request form. It does say in bold "must be submitted by Feb. 1, 2016" but parents can opt out at any time prior to their child's beginning of the test. The Opt-Out form is attached here, is available in the office, or by going to either the district's testing site or the Roseway Heights web page. If you have any questions please contact myself or Mrs. Mosel. The form needs to be submitted to me in the office or electronically.

Our grandparents and special friends day is Thursday, March 17. Our guests are invited to arrive at 1 pm for a welcome and a chance to hear about some of things taking place at RWH. From 1:30-2 they may visit K-5 classrooms. Because our middle school students have three different core teachers (math, science and language arts/social studies) our guests are invited to visit these teachers from 2-2:30 and will hopefully visit the Book Fair from 1:30-2.

Spring break is the week of March 21. I hope it brings sun and time for family and friends.


PPS DBRAC (District-Wide Boundary Advisory Committee) news –

Dear PPS Families,

Cyberbullying is bullying or harassment that happens online. It can happen on a social networking site, in a text message, an email, an online game or comments. It might involve rumors or images posted on someone's profile or passed around for others to see, or creating a group or page to make a person feel left out. Because cyberbullying messages can be rapidly sent to many people, they can cause considerable damage to children. There are many guidelines and resources to help parents navigate and stay involved in their child's online activity. It is our goal to provide families with helpful information about some of the more frequently asked questions related to internet awareness and cyberbullying.

How can I monitor my child's online activity?

It is a good idea to keep the computer in a common area of the house where it's easier to monitor what your child is viewing. Talk to your kids about when and where they can use their cell phones. You may want to establish rules for responsible internet and cell phone use, and you can involve your child in writing family guidelines. Consider using privacy settings to restrict who can access and post on your child's profile. Also consider using filtering or monitoring software. Parents can limit access to certain websites, and can apply filters to email, instant messenger, and chat. Parents should make sure they have their student's passwords to all social media sites. Cell phones also have privacy settings and safety controls, and your phone carrier can help you with choosing the options that are right for your child.

How do I talk to my child about internet safety and cyberbullying?

The most important thing parents can do is talk with their child about online safety and listen to their input. You can discuss privacy settings and your expectations for appropriate online behavior. Help your child to understand what private information is and that they should not post things like passwords, phone numbers, address or family information online. Ask your child to let you know about any uncomfortable experience and to tell an adult if they see something mean online. You can work together with your child to develop a written safety plan, and include specific strategies for what they will do if they are concerned with an online encounter.

What else can I do?

Know which social networking sites your child is viewing and who their online friends are. View their pages and online activity routinely and read the comments. If your child is being bullied you can sometimes block or delete the user name or email address. Tell your child not to respond to an inappropriate message or image, and work with them to save the evidence. Make sure they know you expect them not to participate in any mean conduct, including forwarding or "liking" mean comments.

How do I report offensive or inappropriate online content?

Many social networking sites such as Facebook, Instagram, Twitter, Kik and Vine have links to report threatening, abusive or inappropriate content. You can work with your child to report concerns to the social networking site and ask to have the content removed. You can also help your child review and set up the site's privacy setting and blocking features. Be very cautious about sites that encourage anonymous posts, or that do not have an easy way to report inappropriate content. "Ask.fm" is an example of a site that is commonly used for inappropriate, bullying comments.

What can the school do?

Cyberbullying can happen anytime, 24 hours a day. It is primarily the responsibility of the student, family and community to report and address problems with online harassment. The school is not responsible for preventing and responding to all instances of bullying 24 hours a day. There are restrictions that limit the school's ability and authority to investigate who is being threatening and who will respond to intimidation or threats. Portland Public Schools has an anti-harassment policy that pertains to bullying at school. Parents can report harassment that occurs during the school day to school administration. If the harassment occurs at school, it will be investigated and if applicable, school administration will take appropriate action. In addition, the school is a community partner and can provide information and resources for families.

When do I notify the police or the school?

If bullying continues, you can save the evidence and help your child report it. Ask your child to tell you if an online message or image makes them feel threatened or hurt. If you fear for your child's safety, contact the police. To report incidents of threatening or harassing behavior outside the school day, contact the police. If the cyberbullying occurs during the school day, during school-sponsored activities, or substantially interferes with the school environment, you should report it to the school. The school will work with you, your child and, if appropriate, law enforcement to investigate the concern.

Understanding the ways in which you can talk with your children, monitor their online activity and report instances of cyberbullying will go a long way toward ensuring that you and your children are aware of potentially harmful things on the internet. FREQUENTLY ASKED QUESTIONS

What is bullying?

Sometimes people don't get along. This is not always bullying. Bullying and harassment is behavior that makes someone feel intimidated or offended. Bullying or harassment is unfair, one-sided, repeated and one person may be using their power over another person.

What are Portland Public Schools rules about bullying?

Portland Public Schools is committed to maintaining a learning environment that is free of harassment and bullying. Harassing or bullying is strictly prohibited. Students shall avoid any conduct or action that could be characterized as harassment or bullying.

Students violating this policy shall be subject to disciplinary action, up to and including expulsion. (Administrative Directive 4.30.021-AD)

Are there particular students that might be especially vulnerable to bullying?

When children perceived as different are not in supportive environments, they may be at a higher risk of being bullied. This includes but is not limited to lesbian, gay, bisexual, or transgender (LG8T) youth; youth with disabilities or special health care needs. A child might also be bullied due to the religion or faith they practice; their race, ethnicity, or nation of origin.

What do I do if I think my child is bullying others?

Above all-remain calm. Ask questions and gather information. Review the school rules. Remember kids watch everything we do so we need to model respectful behavior and not bully or gossip about others ourselves. Talk to school staff who can help you and your child come up with a plan to change their behavior. See www.cfchildren.org for more tips and tools.

What do I do if I think my child is being bullied?

Again, remain calm. Let them know you are glad they let you know what is going on and that you are going to help. Ask questions and gather information. Help them identify what has and has not worked in the past. Help them identify friends or other students who might support them. Think of solutions and generate a plan together and notify the school so they can be supportive. Remember to check back in with your child to see if the plan is working. Remember-most kids give their parents more accurate information if parents don't overreact.

When would a builying report be made to the school?

If you have asked a person to stop inappropriate behavior and it does not stop or if you don't feel comfortable telling the person to stop-you can use a reporting form or you can talk to a trusted adult at your school.

If you are witnessing a violent act like assault, call the police immediately and inform your school staff as soon as possible.

Who can use the bullying reporting form?

This form is for student and parent use. You can use it to report any student bullying you see at school. If there is concern about an adult bullying- you should speak directly to the principal. If your concern is about the principal you can contact the school's Regional Administrator.

Do I have to put my name on the reporting form?

You can make an anonymous report. However, consequences can not be applied to the person bullying if an anonymous report is the only information available about the situation. All reports are considered confidential.

How long before someone looks at the bullying report I made?

School personnel are required to respond in a timely fashion. For example- if you turn in a report at 3pm on Friday- it probably won't get read until Monday. With that in mind- if it is an emergency situation- go straight to a staff member.

After investigation, school staff will then respond to the behaviors and provide support to the students involved.

How do I know if my bullying issue has been handled?

School staff can let you know if the incident has been handled but any specific consequences or discipline matters are confidential and can not be shared. A list of potential consequences for bullying can be found at: pps.k12.or.us then search pps: Administrative Directive 4.30.021-AD

What if someone tries to retaliate or get back at me for making a report?

If someone retaliates because of a bullying report they can receive disciplinary consequences. pps.k12.or.us then search pps: PPS Harassment and Bullying Policy 4.30.060-P

What do I do if I witness bullying on my way to or from school?

If you are witnessing an assault or other violent behavior- call the police immediately at 911 and then inform school staff as soon as possible.

If a person is not in immediate danger - talk to a trusted adult about what to do and then let school staff know as soon as possible.

What about cyberbullying?

If cyberbullying occurs outside of the school day- the incidents shall be handled by parents, guardians, and police. If the cyberbullying incident occurs at school or creates a substantial disruption in the school environment- it should be reported to school staff.

What does our school do to prevent bullying behaviors?

There are lots of ways schools can support kind behavior and prevent bullying. Talk to your principal about what your school is currently doing.

2015-16 Parent Request for Exemption from the Oregon Science and optional Social Science assessments and/or English Language Proficiency Assessment (ELPA21)

TEST EXEMPTION CHANGES FOR 2015-16: Oregon House Bill 2655, The Student Assessment Bill of Rights, was recently passed into law and goes into effect January 1, 2016. Part of this bill allows parents to excuse students from state summative English language arts and mathematics tests by completing a state-provided form and submitting the completed form to the student's school district. This form only applies to the science and English language proficiency assessments.

Under Oregon Administrative Rule 581-022-1910, parents may request that their student be exempted from taking the OAKS Online Science and/or ELPA21 tests to accommodate a student's disabilities or religious beliefs. To best support school planning, please complete and submit this form to the school office by February 1, 2016. If a student is enrolled in a PPS school after February 1, 2016, and you wish to exempt your child, please complete this form and submit to the school office within two weeks of enrolling. Alyssum: 4" tall, fragrant white edging for borders or patio pots. Sun or shade. Likes consistent moisture.

Cosmos Mix: 24"-30" tall for full sun. Pink, white, rose and magenta mixed. Full sun.

Dahlia, Dwarf Mix: 12" tall, full sun. A mixture of cheery colors for planters or beds. Full sun.

Fibrous Begonia Mix: 10" tall; pink, white, and red. Plant in light shade or sun; in pots or borders. Impatiens Mix: 10" tall, colorful mixed colors for shade or morning sun; grow in rich, moist soil.

Lobelia Upright: Blue-purple bloom with compact foliage, upright form for pots or beds. Sun or shade.

Lobelia Trailing: Trailing brilliant blue for hanging baskets and rock walls. Sun or shade.

Marigold Dwarf Mix: 12" tall; yellow, orange, and rust blooms for sun. Great for patio pots! Full sun.

Marigold Dwarf Yellow: 12" tall, with clear yellow flowers. Plant in patio pots and flowerbeds. Full sun.

Pansy Mix: 8" tall plants, with bright colored blooms for sun or partial shade. Water deeply in hot weather.
