Violations to any parking and driving rule may result in loss of parking privilege and/or school discipline. Motorcycle drivers must also obtain a permit and follow all parking and driving rules.

PERMITS:

The Permit covers all 118 student numbered spots at WHS and 30 Wilson identified spots at Rieke Elementary School. Spots are for permitted vehicles on a first come, first served basis. Drivers parking their vehicles on school premises must have: (1) all fines and fees paid. (2) approved registration form with student and parent signatures, copy of valid proof of insurance and driver's license, (3) parking permit with permit number visible inside car while parked on campus. (Hanging the permit from the rear-view mirror is preferred).

PARKING

Parking regulations are strictly enforced. It is a privilege to park on school grounds. Loss of permit, towing of vehicle and/or school discipline may be imposed when these rules and regulations are violated. Students applying for and receiving parking permits should fully understand their responsibility in following the rules. (1) The parking lot is reserved for students who pay the fee and agree to abide by the parking/driving rules. (2) Parking on school premises is limited to those who have legally registered vehicles and drivers licenses, and who obtain a parking permit through the established process. (3) **It will be the responsibility of the student driver to insure that the permit, including the permit number, is visible from the outside of the vehicle (hanging the permit from the rear-view mirror is preferred).** (4) **Students may not park in designated staff or visitor parking areas under any circumstance.** (5) Parking is not permitted in the fire lanes, disabled person's parking stalls (unless student has a valid disabled person's parking permit), or open and unmarked areas. (6) All vehicles must be parked within the lines of a designated parking stall. One car per stall and one stall per car.

OVER

DRIVING (1) All students must be licensed and covered by insurance. While the school makes a concerted effort to maintain a safe and orderly campus environment, the school is not responsible for vehicles, its content, or damage to private vehicles either on or off school property. The school is not responsible for theft or vandalism that may occur to a vehicle while parked on our lot or in the vicinity of the school. (2) Speed on school campus is to be kept at or below 5mph and drivers must operate their vehicles with due care and caution at all times. (3) Driving on or across islands, curbing, pedestrian walkways or other areas not dedicated for vehicles is not allowed. (4) Inappropriate driving may result in loss of parking privileges, school discipline and /or traffic citation from law enforcement.

WARNING TICKETS: Campus security will issue warning tickets for violations to the above rules. If a serious driving violation has occurred, student may also receive a traffic citation from law enforcement. Drivers who receive repeated warning tickets for violations to school parking and driving rules will be subject to school discipline, loss of parking privilege and towing of vehicle at owners' expense.

PARKING LOT SEARCHES: I agree that when parking on school grounds, I will not bring weapons, alcohol, controlled substances (i.e., any unlawful substance or drug not prescribed to me by a licensed health care provider), tobacco, or other contraband items which are prohibited by law or school and district policy. This will terminate my parking permit with the school as well as discipline from the school and/or legal action.

I understand that my vehicle parked on school grounds may be searched by school officials, or by law enforcement at a school official's request, if school official's have reasonable suspicion that I or someone who has been recently transported to school in my vehicle or that has been recently present in my vehicle while the vehicle is on school grounds has violated the law or school rules. I consent to a search of my vehicle under these circumstances.
