Large numbers of teachers, principals, operating costs, etc are just required. So we, in my opinion, should separate out the parts that aren't set in stone and have a laser focus on the choices there and the process behind them and the outcomes they obtain
 - ii. Jackson Weinberg: I want our future discussions to really focus in on the RESJ lens, which I know is already mentioned, but also more broadly to how PPS supports historically underserved communities. I also hope to see performance measures included in the budget
 - iii. Irina Phillips: I agree with Judah. Let's leave the basic that is non-negotiable... & concentrate our attention on choices & dilemmas.
 - Roger Kirchner: Historically, it has been the aspiration for CBRC to start in the fall to receive briefings on elements of the budget e.g. SPED, ESL, IT, Counseling, Libraries, etc. Once the Superintendent proposes a budget, CBRC turns its review to that document in preparation to present recommendations and its review of the LOL.
