On December 18, 2018, the Portland Public Schools Board approved the Budget Calendar for the 2019-20 school year (Resolution No. 5783). Later, the TSCC (Tax Supervising & Conservation Commission) granted delay of the submission of the Proposed Budget to TSCC.

ORS 294.635 states the Approved Budget must be filed with TSCC no later than May  $15^{th}$ . However, TSCC has extended the approval date to May  $28^{th}$  and this will allow more time for budget development and budget review. The changes are as follows:

- Moved the Proposed Budget from April 16<sup>th</sup> to April 23<sup>rd</sup>
- Moved the Approved Budget from May 14<sup>th</sup> to May 28th
