**Subject**: Revised 2020-21 Budget Calendar due to COVID-19 Pandemic

#### **BACKGROUND**

On October 15, 2019, the Portland Public Schools Board approved the Budget Calendar for the 2020-21 school year (Resolution No. 5985), aligned with PPS ReImagined, Student Success Act (SSA), and a Multi-Year Business Plan.

On December 13, 2019 (Resolution 6004), the Portland Public Schools Board approved a revised 2020-21 Budget Calendar to allow more time for the SSA Community Engagement meetings and to complete the plan for the SSA as required by the Oregon Department of Education.

# **RELATED POLICIES/BEST PRACTICES**

The District adheres to Government Financial Officers Association (GFOA) and Association of School Business Officials best budgeting practices and Oregon Budget Law.

#### **ANALYSIS OF SITUATION**

Due to the ongoing spread of COVID-19 in our community, and the need for additional economic forecast information to be received on May 20, it is necessary to revise the remainder of the Revised 2020-21 Budget Calendar as follows:

- Publish 1<sup>st</sup> Notice of Budget Committee Meeting: from March 29<sup>th</sup> to May 15<sup>th</sup>
- Publish 2<sup>nd</sup> Notice of Budget Committee Meeting: from April 12<sup>th</sup> to May 17<sup>th</sup>
- Proposed Budget Message and Presentation: from April 21st to May 26th
- Public Engagement on the Proposed Budget: from May 6<sup>th</sup> to May 26<sup>th</sup> and June 11<sup>th</sup>
- CBRC Report to the Board: from May 19th to week of June 9th
- Approval of Proposed Budget: from June 9th to week of June 9th
