I want to open this newsletter with a recognition of the momentous occasion that took place last Wednesday, January 20th-the Inauguration of our new President, Joe Biden, and our new Vice President, Kamala Harris. #### **Limited In-Person Instruction (LIPI) at Llewellyn:**

Since there have been some questions, I want to review information and update you all on a few more details regarding Limited In-Person Instruction shared in last week's newsletter. Again, I want to reiterate that the return to school for students *would not* begin with the whole student body returning, but rather a <u>smaller number</u> of students based on needs determined by school staff. This is called Limited In-Person Instruction, often referred to as LIPI.

### LIPI will include:

- -Cohorts of students no larger than 20 (depending on safety guidelines for the classrooms used-many of are classrooms are to only have up to 10-12 students) in grades K-3
- -Will occur in the afternoons (times to be determined between the hours of 1-4:00pm) 2 days/ week for 2 hours
- -Learning will be supplemental to the Distance Learning being used at this time
- -There is a possibility that students would work with a teacher that is different from their classroom teacher.
- -School Bus transportation will be available.
- -Distance Learning will continue for all students.

While you may have heard that some PPS schools will be beginning LIPI as early as January 25th, <u>Llewellyn is not scheduled to begin until the beginning of March</u> (rather than late February as stated previously). This timeline is subject to change.

While I realize from this description you may feel you do not have a complete picture of how LIPI will look in action, I am curious as to how all of you are feeling about sending your children back to school in this format? If your child was invited to be a part of a small group of students who would come to Llewellyn two days per week for two hours to work on foundational skills, social emotional learning, social skills, or other important skills, would you be willing to have them participate? #### **Report Cards:**

On Friday, February 5th you will receive your child's Quarter 2 Report Card. These will be emailed as in the fall. (Note: If you need a paper copy mailed to you, please let your child's teacher know and we will get that to you.) Remember, the Q2 report card will look very different from the Fall Progress Note. For more details regarding grades or markings that will be used, please refer to last week's newsletter. #### **Assessments:**

Over the next few weeks teachers may be assessing students in preparation for completing report cards as well as other state required assessments. Assessment types and schedules will be shared by your child's teacher. Most assessments will occur during regular class time, and be of a more routine nature such as a math unit test. One exception to this will be a required assessment for our Kindergarten and new to Llewellyn 1st Graders. Senate Bill 1003, otherwise known as Oregon's Dyslexia Legislation, requires that all Kindergarten and new first grade students in Oregon public schools get screened for signs of Dyslexia. Kinder and 1st Grade teachers will be sharing more information about the test and test schedules with you soon.

#### **MAP Assessments:**

PPS will have a MAP testing window for grades 3-8 in math and reading from February 1-26. Earlier this month, you should have received an email from Dr. Shawn Bird, Chief of Schools, explaining MAP testing and outlining the benefits of your child's participation. A Copy of that letter can be found HERE. We respect and understand that given the unprecedented times we are all experiencing, that you may choose to not have your child participate. Teachers will do their best to make this as positive an experience as possible.

### From the District:

#### FREE/REDUCED ELIGIBILITY FOR PEBT AND OTHER BENEFITS

While meals are served at no cost to children ages 1-18 at several Portland Public School sites this year, there are several benefits for eligible families to submit a meal application this school year.

- Families approved for free and reduced-price meals may be eligible to receive future potential government assistance such as Pandemic EBT benefits.
- Families may be eligible for other benefits such as school related fee reduction or waivers, low cost internet and health coverage.

Families do not need to submit a meal application if any of the following apply:

- All students in the household attend a Community Eligibility Provision (CEP) school (list located online: <a href="https://www.pps.net/Page/2088">https://www.pps.net/Page/2088</a>) where students eat meals at no cost.
- A meal application has already been submitted and approved for the 2020-21 school year.
- The household received a 2020-21 Direct Certification Approval letter.
