

I am thankful this Friday that many people in Portland, including many of you, and members of our school staff have received or will very soon receive their first **COVID-19 vaccine** dose. It brings a feeling of reality that we will be able to safely work with students in person soon. We are grateful to the Governor and PPS for making this possible.

As mentioned in previous emails, we are finalizing **Llewellyn's Limited In Person Instruction Plan**. As soon as it is approved, I will be holding a <u>Parent Information Night</u> for the grade level families that will be involved. MAP Assessments:

PPS will have a MAP testing window for grades 3-8 in math and reading from February 1-26. Earlier this month, you should have received an email from Dr. Shawn Bird, Chief of Schools, explaining MAP testing and outlining the benefits of your child's participation. A Copy of that letter can be found HERE. We respect and understand that given the unprecedented times we are all experiencing, that you may choose to not have your child participate. Teachers will do their best to make this as positive an experience as possible. Teachers will notify you and your students the dates for which they will be completing MAP assessments.

From the Llewellyn TAG Coordinator:

Hello,

This month we have turned in all final paperwork for TAG nominations. The district is currently at a stand still in regards to finalizing these nominations. The TAG department is watching to see what happens with LIPI so that they can conduct the testing needed for certain students, and we are also waiting for MAPS testing to occur in February. These assessment scores are data sources we use in order to establish the TAG label for students. For those students who qualified from these assessments that they took last year,

you are still in the same waiting period, but rest assured you can know that your student will obtain it. Please also be aware that this process usually takes most of the school year, and that TAG labels are usually officially given to students in SYNERGY the following year. I want to thank everyone for their time in completing the google forms for nominations this Fall, all the forms were correctly completed, and we can now move forward in the process (this is just the long waiting game step in the process).
