Dear Families,

As we work to finalize our school's plan for the return of many of our students in-person along with the continuation of Distance Learning, I am grateful to our teacher teams for their creative thinking and efforts to collaborate to continue to provide the best learning experience for ALL our students as we can. I am grateful to you, our students' parents as well, for completing the survey and sharing your thinking around the different models of learning proposed. I continue to be incredibly grateful for your continued patience while you wait for the plan details to be announced. We know you are anxious to hear the details in order to make plans for you and your families.

As I shared at the PTA meeting last Tuesday, about two-thirds of our school population would like to participate in the hybrid model, while one-third has chosen to remain in CDL. While the original plan was to begin the Hybrid/CDL model in April, the Governor's recent executive order mandating that students begin in-person learning, means that our starting date is currently expedited to be the week of March 29. We have also been told that new guidelines from the Oregon Department of Education (ODE) may arrive soon which will mean we will need to make revisions of our current plans. Additionally, negotiations with our labor partners are continuing. These are the main reasons we cannot share our final plans just yet.

I *can* tell you that Mondays, Tuesdays, Thursdays, and Fridays students will be participating in either Hybrid or CDL as part of a morning or afternoon cohort. Wednesdays will most likely be asynchronous and small group work. All K-5 schools will follow the same bell schedule. Morning cohorts will be from 8:00-10:15 and afternoon cohorts will be from 12:15-2:30pm. When students are not in live instruction, they will participate in asynchronous activities (much like we do now). The focus during live sessions will be on Social-Emotional Learning, Literacy, and Math. Other subject areas, such as science, health and social studies, will be asynchronous. Our current specials: music, PE, Movement will be offered both live and asynchronously. Special Education services will also continue such as speech, OT, and Learning Center support. As you might guess, the schedules for these services will need to be adjusted.

In creating the student cohorts, our intent is to keep siblings on the same time schedule to ease family planning. Additionally, knowing how important the relationship is between students and their teachers, we are working hard to keep students with their current teacher, but this may not be possible in all cases. As you might guess, one of the biggest challenges affecting student placement at Llewellyn is finding classrooms and learning spaces that can accommodate large class populations while following all guidelines to keep our students safe. We are working diligently to find ways to mitigate these space issues. Please know that we understand changing teachers at this point in the year will be challenging, but we will do our best to get our students through this feeling safe, cared for, and supported.

I'd like to end with two positive pieces of news and that is that every classroom will be equipped with an air purifier. We are fortunate at Llewellyn to have working windows in every classroom, new air filters in all our

ventilation registers, and the ability to open our classroom doors inside the building. This should keep the air in our classrooms moving!

The second bit of positive news is that next year our staffing will remain the same. While our population has changed over the course of this year, the district has taken into account that many families will return to their home school once school begins next fall. While many schools will see several cuts in staff, our staff loss was funding for half of a counselor position. We need to have 500 or more students to keep both full-time counseling positions. Fortunately, after discussing options with our Foundation, we are able to cover that loss using Foundation funds. I can't think of anything we will need more next year than the support of our AMAZING counselors for our students as they return to school next fall. Thank you to the Foundation for supporting our students social emotional health and to all of you for making this possible through your donations!!!!
