Feedback Comments  I was frustrated with the process for considering the input from our communities of color based on	Themes Process
survey and focus group data. While I am really glad that we are identifying and elevating this feedback, we were unable to process it with 5 minutes to skim over the information and then try to synthesize it in a meaningful way. I understand not wanting to put additional burdens on people during the week, but if we are going to discuss something in the meeting, we should have been given the opportunity to prepare ahead of time. The process for reviewing the feeder options felt the same waywe needed to use our group time to make sense of what we had been given, rather than to collaborate on the proposals, and by the time we were ready to get into it, time was up. We need to figure out how to make more productive use of our limited time together, and that might mean more expectations to come to these meetings ready to share some thoughts, rather than figuring everything out as we go so that by the time we are ready to discuss, the meeting is over. My request would be that we be charged with creating two sets of feeders for Kellogg: The best we can come up with that plans for all-DLI at Lent, and the best we can come up with that plans for a balanced co-located program at Lent (2 strands DLI, 2 strands neighborhood) and a 2nd 2-strand DLI program elsewhere. At that point we can possibly decide which of these to send on to the board, or possibly send them both and let the board decide what fits best with the district's vision.

C) Giving me 8 minutes to read and respond to a 20 page document is not enough time. It's not allowing me to actually be thoughtful and responsive to the documents and the thoughts of families. This should have been sent out ahead of time, or we should have been given more time and other things should have been pushed out. Someone said tonight that we are being given enough time to "be reactive, not responsive", which I think is spot on.	
D) I would like data for these scenarios to include projected enrollment for all affected middle schools so we can make truly informed decisions. This was brought up in my group several times, but when I asked for this data, I was told to look at the initial enrollment data provided in one of the first sessions - I do not want to do these calculations myself using that initial data and these scenarios data. I have been a math teacher and perfectly capable of doing that, but there's a really wonderful data analysis team who can probably do it much faster, better, and make the results more readable than me. I want to be fully informed.	
E) I feel like the issue of transportation is being solidly ignored. I realized that it's a primarily K-5 issue, but would like distance and bus info if at all possible. This is the biggest concerns I have heard from families at both of the schools I am hearing from and it showed up in the community data over and over also.	

Feedback Comments	Themes
Homework. It would be great to get a packet for the meeting with the questions we will be asked to consider in advance of the meeting. Set goals for each meeting - deciding on a feeder pattern for Kellogg is the goal of the last meeting. Establish rules to guide us such as walkability and avoiding segregation if that is what we believe the community wants. Identifying questions that we feel must be answered before attempting to solve problems for which we don't know the questions. Stop presenting scenarios that have not been fully thought through and asking the group to pick a "menu" item and instead focus on crafting a strategy that meets community expectations and serves the students. Our group spent time trying to decide why the feeder patterns were created. We should know that first without having to guess if we are given "menu" items rather than spending valuable time deconstructing a proposal.	Time Process
I think there were so many variables to hold in our heads at once that it lead to paralysis. The graphics of the scenarios in phase 1 and 2 were clear and fairly simple to consider, until trying to add in implications for school size, geographic location, implications for phase 2 DLI placements and other feeder pattern shifts to right size schools, especially in the case of the creation of the second new middle school in 2022/23. Providing an enhanced graphical display that can help us visualize all of these variables may allow people to discern variations in impacts that would allow us to push forward options that coincide with the feedback of BIPOC communities that we reviewed at the beginning of the meeting. That's a tall order in terms of data processing and graphical design, but it feels like what we are asked to do on our own in order to be able to offer useful feedback.	Time Process Feedback
