## What other suggestions do you have?

Are we stuck to the North and South of Powell option on #3? Can we change the boundaries again?? Can FLO provide the numbers for what would happen if we incorporated all 3 supplemental options? Neighborhood students ONLY + leaving Spanish DLI @ MTMS + Creston south of Powell + 25 Bridger hold south of Division would have an enrollment around 617 (~80%) utilization rates, it looks like if we don't stick with the original recommendation, that we potentially need to combine all three additional solutions--keep Atkinson's SI at MTMS, eliminate transfer students.
