# **Purpose**

The ACCESS Academy Advisory Group will advise the leadership team in identifying a location for the program in the both the short-term and long-term and will address a variety of factors involved in making a final decision including: facility capabilities, boundaries, programmatic and staffing needs and requirements for a successful implementation. The Advisory Group will provide their own expertise and perspectives and will seek the input from others in forming a recommendation to the Superintendent.

### **Duration**

In place until long-term solution is determined or if significant, impactful changes or decisions about the program are necessary.

## Membership

Group membership will consist of district leadership, school staff and parents or family members of the ACCESS Academy community. Specialists or outside experts may be invited to address special topics. The regular membership of the group will not exceed 20.
