In lieu of a team-based meeting, a family who is not able to meet with their neighborhood school may still apply using the Access Application for admission, and a statement of need from an educator/counselor who knows the child best.

Once the application is completed and all required information is provided, the student is eligible for the ACCESS lottery, so long as a SchoolMint application has been submitted as well.
