

Dear Friend and Supporter,

This letter confirms that the Portland Public School "Local School Foundations" listed below are under the umbrella of **The Fund for Portland Public Schools**, **Federal EIN #84-2040549**. These local school foundations all operated under the nonprofit All Hands Raised up until June 30, 2019.

This letter also confirms that The Fund for PPS has filed for tax-exempt status under Internal Revenue Code Section 501(c)(3). In accordance with the IRS, the IRS will approve a timely exemption application and recognize that exempt status back to the date the organization was created which was June 10, 2019. Thus, while our exempt status application is pending, the IRS allows for The Fund for Portland Public Schools to treat itself and operate as an organization exempt from federal income tax under section 501(c)(3).

We anticipate approval and confirmation from the IRS will be forthcoming by no later than October 31, 2019. During this pending period, if supporters prefer to donate to an established tax-exempt organization, they may do so to Portland Public Schools (DBA: School District 1J Multhomah County; EIN #93-6000830).

In the meantime, we thank you for your generous donation and contribution to Portland Public Schools and The Fund for Portland Public Schools. Together, we are all helping prepare our students to lead change and improve the world.

Thank you for applying for an Employer Identification Number (EIN). We assigned you EIN 84-2040549. This EIN will identify you, your business accounts, tax returns, and documents, even if you have no employees. Please keep this notice in your permanent records.

When filing tax documents, payments, and related correspondence, it is very important that you use your EIN and complete name and address exactly as shown above. Any variation may cause a delay in processing, result in incorrect information in your account, or even cause you to be assigned more than one EIN. If the information is not correct as shown above, please make the correction using the attached tear-off stub and return it to us.

When you submitted your application for an EIN, you checked the box indicating you are a non-profit organization. Assigning an EIN does not grant tax-exempt status to non-profit organizations. Publication 557, Tax-Exempt Status for Your Organization, has details on the application process, as well as information on returns you may need to file. To apply for recognition of tax-exempt status under Internal Revenue Code Section 501(c)(3), organizations must complete a Form 1023-series application for recognition. All other entities should file Form 1024 if they want to request recognition under Section 501(a).

Nearly all organizations claiming tax-exempt status must file a Form 990-series annual information return (Form 990, 990-EZ, or 990-PF) or notice (Form 990-N) beginning with the year they legally form, even if they have not yet applied for or received recognition of tax-exempt status.

Unless a filing exception applies to you (search www.irs.gov for Annual Exempt Organization Return: Who Must File), you will lose your tax-exempt status if you fail to file a required return or notice for three consecutive years. We start calculating this three-year period from the tax year we assigned the EIN to you. If that first tax year isn't a full twelve months, you're still responsible for submitting a return for that year.
