

Portland Evening and Summer Scholars Information & Policies

Student Responsibility: PES is a voluntary supplemental credit recovery program operated by Portland Public Schools. Students enrolled in PES have the responsibility to follow all rules in the most current District Student Rights & Responsibilities Handbook. Attendance Policy: Attendance is crucial. There are no excused absences, including absences due to late enrollment. Students who miss more than 3 classes may be withdrawn. 3 tardies = 1 absence.

Courses: Each successfully completed course earns the student one-half (1/2) credit. Classes may be cancelled due to insufficient enrollment, lack of space, or availability of a teacher. All decisions regarding class and teacher assignment are made by the PES administration.

Tuition and Refunds: (Tuition is due in full at the time of registration)

Students living <u>within</u> PPS boundaries or attending a PPS school	\$200
Students living <u>outside</u> PPS boundaries and not attending a PPS school	\$225
Students living <u>within</u> PPS boundaries, and who <u>qualify for Free/Reduced Meals</u> (must provide verification):	\$35

We accept cash, check or money order (payable to: PPS) and VISA or MasterCard credit/debit cards.

Refunds: Requests for refund must be done in person or over the phone and made no later than the end of the 1st week of classes of classes: July 1, 2022 for Session 1 and July 22, 2022 for Session 2. Please allow 6-8 weeks for processing after contacting the office.

Instructions for this form: Please meet with the counselor at your school to ensure you are selecting the correct PESS classes. After the form is complete and signed, please return the form via email to khanson2@pps.net. The deadline to enroll for Session 1 classes is Thursday, June 23, 2022.

When selecting classes, please be aware that some classes are offered in In-Person and Online formats. In-Person classes are held at a variety of locations. Please select the class and location combination from our updated course list at pess.pps.net.
