- State of the Union (Kristina Howard)
 - Kristina is sitting on the district-wide budget committee, feels as if she is being heard by the budget committee re: TSI funding, OG will retain supports in '20-'21
 - 500 is the "magic number" for enrollment next year for retaining FTE. At the moment, that is our projection.
 - PLCs continue, feedback generally good
 - Will be a bump in the referral numbers for December due to an incident that happened during the climate walkout
 - Kristina and Mr. L will again try to elicit more teacher participation in SC

 - Common themes in areas for improvement: Communication, facilities, lunch, academic rigor, and behavior
 - Add "my child has a voice to next year's survey"
 - Past survey reports
