#### **Behavioral Expectations**

The safety and well-being of all participants and staff is of utmost importance. To ensure safety in the SUN Community Schools, we require that all participants be able to follow all of the following criteria:

- **1.** Be age-appropriate for the activity or program.
- 2. Be able to maintain safe behavior during the activity. This means they can participate without harming themselves
