Dear Educators,

Together, PAT and PPS have finalized the staffing process for educators whose placement will be impacted by the Southeast enrollment and program changes. This message provides a brief outline of the process and includes an action item. Please read the message carefully.

The full PAT-PPS Letter of Agreement is available online <u>here</u>. We have also collaborated on this <u>Frequently Asked Questions (FAQ)</u> document which we hope answers most of your questions.

Please note, PAT employees currently at <u>Bridger</u>, <u>Harrison Park</u>, and <u>Lent</u>, must complete the survey linked below no later than Friday, December 9 in order to indicate their assigned school selection for the 2023-24 school year staffing process.

The following is the basic steps for current educators assigned to the school:

Bridger ES - through <u>this survey</u>, all PAT members will select the school (Creative Science School or Lent DLI ES) to be assigned for the 2023-24 staffing process.

Creative Science School (CSS) - all PAT members will remain assigned to CSS and physically move to the Bridger site.

Harrison Park K-8 - through <u>this survey</u>, all PAT members will select the school (Clark ES or Harrison Park K-8) to be assigned for the 2023-24 staffing process.

Hosford MS, Chinese DLI Educators - Will be offered vacant Chinese DLI position at Harrison Park MS DLI program, prior to the internal round, should there be vacancies remaining after Harrison Park MS completes the regular staffing process. If there are no vacancies, you will be eligible to apply for positions during the internal round. For additional information regarding the unassignment and transfer process, please visit the FAQs.

Kellogg MS - all PAT members will remain assigned to Kellogg MS.

Lent ES - through <u>this survey</u>, all PAT members will select the school (Lent DLI ES or Marysville ES) to be assigned for the 2023-24 staffing process.

Marysville ES - all PAT members will remain assigned to Marysville ES.

Mt. Tabor MS, Spanish DLI Educators - Will be offered vacant Spanish DLI position at Kellogg MS DLI program, prior to the internal round, should there be vacancies remaining after Kellogg MS completes the regular staffing process. If there are no vacancies, you will be eligible to apply for positions during the internal round. For additional information regarding the unassignment and transfer process, please visit the FAQs.

Once staff have completed the <u>survey</u> and selected their school to be assigned to for the 2023-2024 staffing process, school administrators will complete the regular staffing process, as outlined in 18.6.2. using a combined seniority list.
