Course Title: Intermediate Acting	Grade Level(s): 9-12

Prerequisites: Beginning Acting or Similar class from Middle School or Theater Company

Course description: Through self and collaborative exploration, students will develop skills in all aspects of acting. During this course students will continue to investigate, voice, movement, text, improvisation, and performance within focused units of study and build on these foundations from beginning acting.

## Standards:

Priority Standards for unit: • Use basic terms of theatre • Utilize warm-up techniques for preparation of body, voice and mind • Improvise using emotional and sensory recall • Apply stage movement and pantomime technique to express thoughts, feelings and actions of a character • Describe the roles of theatre, film, television, and electronic media in American society. Supporting Standards for unit: • Define the terminology and process of evaluation and apply this process to performances using appropriate theatre vocabulary • Identify, compare and contrast the lives, works and influences of representative theatre artists from various cultures and historical time periods (e.g., Shakespeare, Moliere, Ibsen, Julie Traymor, Peter Brook,
