Site Accessibility

South Entry	Add exterior handrails at steps up to door (approximately 8 lf of rail.) Provide an accessible ramp (approximately 12 lf of ramp.)

North Entry	Entry is at grade and accessible from sidewalk to the basement level. Verify for compliant door hardware and threshold. Provide accessibility signage outside entrance.	
West Front Entry	Verify entry pair door clearances and threshold, and door hardware for accessibility compliance. Stairs at interior. Replace interior stair handrails with compliant handrails with top and bottom extensions (approximately 34 If of rail.)	
South Entry	Add compliant handrails at interior stairs west to classrooms (approximately 14 lf of rail.)	
Elevator A	Add an elevator to access the south portion of the basement, first and second floors, and from the exterior. Suggested location would be outside the south end of the main corridor. This location would access the exterior, the south basement, including the girls restroom and the first and second floors. It does not access the north basement classes or boys restroom.	
Elevator B	Add an elevator to access the north portion of the basement and building. Suggested location would be at the northeast corner of the north interior court. This would access through Classrooms 7 & 17, and Room J in the basement (approximately 40lf of corridor remodel.)	
Ramp / Lift	At the two steps between the Gym and the main building wing main floor level, provide a ramp or lift (or integrate into elevator B solution.)	
Stage	Provide a lift to access the stage (and connect the Auditorium to the Gym along an accessible route.)	
Handrails	Verify that accessible handrails are provided in at least one stair from basement to the second floor. If not currently provided, the northwest stair	

	is recommended (approximately 144 lf of rail.)
Auditorium	Verify interior auditorium entry pair door clearances and door hardware for
	accessibility compliance.
Common Room	Verify that lever or pull hardware is provided at common room doors, and
Doors	provide if needed.
Classrooms	Provide lever handle hardware at all classroom entry doors.
