Boys Lockers (off of Gym)	Provide compliant bench with backrest at portion of existing bench.
Girls Lockers (off of Gym)	Provide compliant bench with backrest at portion of existing bench.
Play Structure	Verify and test (2) existing play structure safety surfacing areas. Third area already has solid safety surfacing. Existing mulch material must be solid enough to support wheelchair access.
Play Structure	Verify that at least one of the existing play structures is accessible, and modify if needed.

Field Notes:

1. Former stage for Cafeteria/Auditorium is now designated as Classroom 115. Is stage still usable as such, or is classroom conversion "permanent"? This classroom still has the stage stair access.

2. Two existing corridor ramps are part of accessible path to Gym common use room. All other common use areas are on main accessible entry level. Ramps are bounded by existing doorways or cross corridors that limit extending the ramps to a compliant slope.

3. Update for Boys 194 and Girls 193 is recommended since they are on the lower wing level of the non-compliant corridor ramp. These restrooms also have direct access to the adjacent outside play ground.
