Site Accessibility

Parking	(2) accessible on-site parking spaces marked and striped, but faded and located across the vehicular way when closer stalls are available. Provide 2 accessible stalls with access aisle and signage (one with van parking sign) on south side of lot closet to north entry.
Main Entry East	Although the north entry is being used as the main accessible entry, there is space to provide a ramp(s) along the exterior route from parking to the main entry that would improve access (approximately 66 lf of ramp) by allowing direct access to the office level. A ramp would also be needed at the single step near the east entry door (approximately 6 lf of ramp.)

Main East Entry	Verify entry (1) pair of doors has minimum 32-inch swing requirement and compliant accessible hardware. Otherwise, replace one set of double doors with (1) 3-0 compliant door.		
Main North Entry	Verify entry (1) pair of doors has minimum 32-inch swing requirement and compliant accessible hardware. Otherwise, replace one set of double doors with (1) 3-0 compliant door. Verify interior directional signage pointing to lift, office and to common use spaces.		
Stair/Corridor	An existing lift at this stair is noted in PPS 1997 assessment connecting the two levels, but is not shown in plan.		
Entry Play Yard	Verify pair of entry doors from the corridor outside the cafeteria to the play yard has accessible clearance and lever or pull hardware at the exterior side.		
Classroom doors	Provide all classrooms with lever handle hardware. (17) classrooms.
