Field Notes:

1. This facility has an unusually low gymnasium ceiling with ceiling mounted troffer lights with partially exposed lamps which staff noted were frequently broken. The age range for classes in the gymnasium is K-12 since it is shared by programs three buildings. The light fixtures should be replaced for student safety.
