The Department of Student Voice & **Community Engagement**

Serves as a central conduit for PPS decision makers to listen to, learn from and involve key stakeholders in PPS' decisions and policy shifts, in service of accelerating the conditions for student achievement.



The Department is comprised of engagement specialists and multilingual community agents whose core functions are to:

Glossary



BIPOC:

Acronym for Black, Indiginous, and People of Color

CDL:

Acronym for Comprehensive Distance Learning

Student-Centered Design:

Curriculum and/or activities that are designed in a way to prioritize the experience and learning of students

Targeted Universalism:

The setting of universal goals that are pursued by specific, targeted processes to achieve those goals.

Universal Design:

The design of physical spaces, learning materials, and more that are created to be accessible to all students, regardless of age, disabilities, and other factors.
