

PROJECT NOTES

Progress:

- Board-directed Cost Reduction Study completed, and a revised design, budget & schedule presented to District leadership.
- Three high school modernization project teams coordinating with each other and with PPS Facilities & Maintenance teams in order to maintain consistency and maintainability of systems across projects.
- Project team meeting with City Major Projects Group as part of new permitting timeline to review code topics.
- Community engagement has continued, with tabling at summer events and a new Community Open House at the start of school

Accomplishments:

- Schematic Design reached 50% SD milestone, with regular weekly design sessions and consultant coordination meetings.
- Revised design presented to internal PPS stakeholders for their review and feedback.
- New Jefferson project CM/GC RFP with revised contract was issued, pre-proposal meeting took place, and evaluation process is underway.

Risks:

- Risk of transition to new CM/GC contractor as part of cost & schedule evaluation in late summer can be mitigated with robust owner + architect team preparation as part of design phase approval process.
- Risk of continued labor shortages and market volatility can be migitgated with careful coordination & planning between three high school modernization project design, permitting and construction schedules.
