1) One more DAG meeting to wrap up past discussions

a) Date TBD through email follow-up to members.

2) Discussion about major site features and parking

- a) Question about other sites that have limited space and how they addressed successfully
- **b)** Expansion potential is limited due to packed site.
 - i) Need to address in future plans

3) Parking Discussion

- a) Traffic Study
- **b)** Concern about number of stalls on site for staff
 - i) Do we really need expanded drop-off zone in front to get more parking in front?
 - ii) Where do parents drop-off?
 - iii) Can RHS get permitted parking on street through the City? (More control and dedicated to staff and students)
 - iv) Student Parking (some) dedicated so they have the option. Zoning for teachers/students (10 stalls?)
 - v) Any partnerships with neighboring lots? (Probably not)
 - vi) Consider relocating field trip drop-off zone more in front of fields so area directly in front of school can be parking
 - vii) Direct pedestrian path to Smith Street would help activate parking on that street. Also better connection to community to North.

4) Concern about gate appearance at athletic plaza

- a) What are the options? Don't want chainlink fence and gate in this area
- **b)** Would Bollards be a better option? More detailed meeting about ticketing and security at the fields with RHS Athletics department will help make determinations.

5) Thoughts about how to address vandalism and glass break-ins

- a) Security Glass/Laminated Glass at lower levels an option. Security grills also a possibility, if aesthetically pleasing
- b) There are no vandal-proof materials. Will be an ongoing maintenance issue

6) Memorial Garden Location

- a) Front and center too prominent
- **b)** Benches and memorials could be by football field flag pole, or near community garden on SE side

7) Community Plaza/Garden

- a) Terraced to flush out grades from plaza to street
- **b)** No plants that attract bees and wasps
- c) Smaller "community" garden (Not to Parks & Recs specifications, but a replacement of existing use)
- d) Call it a "Neighborhood Garden"
- e) Can the garden have a link/adjacency to science classrooms?
- *f)* Contact for existing garden is George Bishop. It was suggested design team talk with him to understand how existing garden is used and maintained.

8) Prominent view from corner of Ida and Central

- a) Good location for school signage
- **b)** This location was also mentioned as a possibility for a replacement reader board.

9) Greenhouse option to tie to the science department?

10) Stormwater

- a) Spread throughout the site
- **b)** Will be planted to look like natural environments. Plant selections will mitigate hiding or other security concerns
- c) Designed to be open, visible and attractive
- **d)** Are green roofs a consideration? (Maintenance and budget considerations make it difficult)

- **b)** Street trees on Central St., if not deemed unsafe, could stay for now
- **c)** Option to replace a few to give time to grow before remaining need to be removed in the future?
- **d)** Consider protection during construction
- e) Street trees (silver maple) a community amenity
- f) If replaced, shade trees would be wanted
