The Small Construction Request for Quote Form is used for public works contracts that do not exceed \$80,000. Since prevailing wage rates vary based on funding source and contract amount, there are separate forms to address these variations.

The matrix above specifies the appropriate form to be used for the applicable wage rates. The provisions below highlight the wage rate provisions specific to each form.

2.2.0 CONTRACT WAGE RATES

District requires Contractor pay equal to or higher than current District Council Unions (DCU) wage rates plus fringe on this project. The current DCU rates are provided here as Attachment B. Certified payrolls must be included with each pay application.

The work scope of this project IS NOT subject to Oregon Bureau of Labor and Industries (BOLI) prevailing wage.

Form 2: Small Construction Quote Form \$2,000 to \$40,000 fed (DB)

2.2.0 PREVAILING WAGES

This project's Work is subject to the Federal Davis-Bacon Act. Quote Provider must comply with federal law relating to prevailing wages. Quote Provider shall include certified payrolls with each pay application to the District.
