FOR REQUESTS TO TRANSFER OUT OF PORTLAND PUBLIC SCHOOL

If you live in the PPS district boundary but wish to have your child attend school in a different district, you must receive permission from both districts.

The PPS Board agreed to release all students with the following qualifications:

- Students who had a legal change of residence into the PPS district since the summer of 2018
- Students not yet enrolled in a district where their co-enrolled sibling(s) attends
- Students who have been attending a public charter school in a different district for at least three consecutive years and are completing the highest grade this year.

PPS resident students must also receive permission from their requested district before the start of the 2019-20 school year for the release to be valid. Releases to other districts remain in effect through 12th grade.

Applications must be received in the Enrollment and Transfer Center by September 1, 2019. In order to meet June 1 deadlines at other districts, submit your request by 5 pm May 24, 2019.

Students who do not meet the criteria above will <u>not</u> be released from PPS through the standard interdistrict process.
